Please Read and Sign

In case of emergency, the owner designates Dog Baths and Beyond as agent and understands that whatever is appropriate for the well-being of the pet's health will be done. If services of a veterinarian are required, the owner extends permission for treatment. Such expenses will be paid promptly by owner. The health and safety of your pet is our primary concern. If the pet becomes unmanageable and cannot safely be groomed, services will be discontinued to avoid injury to pet or groomer.

We will not be responsible for clipper burn and/or minor nicks resulting from grooming of hard to handle dogs, aggressive dogs, matted, neglected coats or irritation caused by removing coat from pets possessing mild to severe skin allergy, or stressful effects grooming may have to an elderly pet. We will not be responsible for accidental death of pet of the nature of pre-existing health conditions or natural disaster. We are not responsible for injury or sickness caused by the pet to itself.

Owner is responsible for any damages that is caused to facility by themselves, children or pets

Any injury or grooming related complaint is to be brought to the attention of the groomer within 48 hours.

We reserve the right to refuse service to customers whose pet may pose a threat to groomer or other pets in our care, whether it is an aggression, health or parasite problem.

Owner agrees to be responsible for any property damages by pet.

_____ If you fail to show up to your appointment without notice of at least 24 hours a \$25 no show fee will be applied per dog that was a no show. Habitual missed appointments or cancellations will result in a non-refundable deposit or prepay before another appointment will be scheduled. If you are more than 10 minutes late you may need to reschedule your appointment up to the discrepancy of the groomer. Late fees may apply

Nail Trimming

(please read and initial)

_____ Dog Baths and Beyond will always attempt to dremel nails before clipping unless instructed otherwise. Muzzles maybe used along with leads to restrain your pet during the nail trimming process for the safety of your pet and the groomers. If your pet is showing signs of extreme distress during the nail trimming process the Dog Baths and Beyond associate will end the nail trimming session even if all nails are not completed. If your pet requires more than one person or a muzzle additional charges will be applied. Nail trimming is done in the back area to avoid distractions and distress on the pet itself. Accommodations can be made in special needs cases.

Self Service

(please read and initial)

_____ We offer self-service bathing only. Self-Grooming is NOT permitted under any circumstance!
No outside clippers/scissors/blow dryers or nail trimming tools permitted. Attempting to cut a pet's hair or nails by an untrained professional can be dangerous and harmful to you and your pet. If you violate this policy you will be asked to leave without a refund. If you would like grooming or nail trimming please ask one of our staff members and we will be more than happy to help you. Personal shampoos and brushes are allowed

Pets only in the tubs and restrained with lead per state regulations (PACFA) , it is a safety hazard for you or your child to be in the tubs.

You and your child must be fully dressed including shoes

Please watch your children and pets for the safety of all parties not all animals are accustomed to small children or other animals
